Work Experience

Aug 1999 – present: Owner, Director and Management Consultant, Manator Aps

In August 1999 I started as self employed with the firm “KvalitetsService” (translated: “Quality Services”). In 2004 it was transformed into the PLC “Manator Aps”, where I am the owner, director and operating as management consultant.

What I do – and some history:

Since 1999 my consulting services have mainly been about **development and implementation of quality and environmental management systems**, business process improvements as well as supporting clients with my personal resources - carrying out the related tasks as a **consultant or as sourced quality manager**.

- As such I have been the clients external project manager, advisor and coach, e.g. working with business and process analysis, project plans, budgets, managing change processes, **internal auditing, FMEA, MSA** etc., until – as well as after – **certification of the management systems**, where applicable.
- I am also **tutor** at Manator Aps’ training courses on implementation and auditing of management systems.
- Since 2016 I have also been sub-contracted as **QA consultant on large projects** in the process industry.

Since 2002, I have been working as sub-contracted **ISO 9001** Lead Auditor for Bureau Veritas Certification A/S (BVC).

- In 2015 my Lead Auditor work was added **IATF/TS 16949** Letter of Approval (LoA). These are 3rd party audits on ISO 9001 added all requirements of the automotive QMS-standard IATF/TS 16949 and its applicable tools. These LoA audits are relevant to companies who want to comply fully with IATF 16949, even though they do not have automotive customers.
- In 2017 I have added **APQP4Wind** competences and have been approved as tutor on Bureau Veritas’ open and company specific APQP4Wind courses. As such I have trained and certified several APQP4Wind Specialists and managers at Management Awareness courses in Denmark and Spain.
- Since 2019 my Lead Auditor and Consulting work was added **ISO 28000/28001**, Supply Chain Security.

In 2004 Manator Aps launched a networking service for SME directors **Ledelsessystemer.dk** (translated: *Management Systems*). Also in 2004, Manator Aps acquired a specific risk-analysis tool along with employing the developer of the tool. This partner had the business responsibility for developing the markets for the product. In 2008 the owner established his own company, continuing the cooperation with Manator Aps.
